



## **What is the Utah invisible condition alert program?**

The invisible condition alert program is designed to help alert first responders to a person's invisible condition which may explain otherwise concerning behavior. Under this program, someone who has certain physical or mental conditions that could impact their ability to communicate with a first responder, can sign up to participate.

This program helps first responders understand how to best interact with individuals. By identifying an invisible condition early in an encounter, first responders will be more aware of the situation they are going into and have a better opportunity to respond appropriately.

An individual must complete a form in partnership with their healthcare professional. The completed and signed form must be submitted to the Driver License Division (DLD) by mail, fax, email, or at an office location. This contact information is found on the request form.

An individual may also add an invisible condition to their motor vehicle record. To add an invisible condition to your record, visit the DMV invisible condition site for the form to complete. ### Invisible Conditions

This program allows for an invisible condition identification symbol to be applied to a driver license or identification card.

Invisible condition means a physical or mental condition that may interfere with the ability to communicate with a law enforcement officer. For example:

- Communication impediment
- Hearing loss
- Autism spectrum disorder
- Drug allergy
- Alzheimer's disease or dementia
- Post-traumatic stress disorder
- Traumatic brain injury
- Schizophrenia
- Epilepsy
- Developmental disability
- Down syndrome
- Diabetes
- Heart condition
- Other condition identified by a health care professional
